Explanation of Holland Company Lot numbers

The initial letters of a lot number signify the product type:

KA – Potassium Aluminum Sulfate

AA – Ammonium Aluminum Sulfate

HC – Iron Free Dry Aluminum Sulfate

Following the product type, Holland Company uses a numbering system for its product lots. New lots have an increasing number applied and do not reference dates or lot sizes or other factors. For example, if the previous lot of our Aluminum Sulfate was "HC 0405", the next lot manufactured in the future would have a higher number "HC 0406".



Statement on Natural Product / Ingredients

Holland Company produces several types of Dry Aluminum Sulfate based products, including Ammonium alum, Potassium alum and Iron Free Aluminum sulfate. These products are manufactured using natural raw materials mined and then purified to produce the end product. The Holland Company products are not removed directly from the earth, but the ingredients and raw materials are. The process does not add any synthetic materials, but the final product is altered in a way to produce a purified material suitable for use in food and cosmetic applications.

SHELF LIFE STATEMENT REGARDING OUR DRY ALUMINUM SULFATE PRODUCTS

Holland Company states that there is no expiration date on our Dry Iron Free Aluminum Sulfate, Potassium Aluminum Sulfate or our Ammonium Aluminum Sulfate. This covers the *Technical Grade* and *Food Processing Grades*. The products are listed as having an "Indefinite" shelf-life, or noted as "none" when an expiration date is requested. The products do not de-grade with extended storage.

We have determined that the USP Grades of our products have a three year shelf life from the date of manufacture. If the USP grade is past the three year shelf life, under certain circumstances, a product sample can be sent to Holland Company for possible extension of the shelf life.
