Provided, however, that where any articles are packed or delivered under a label designed or furnished by Buyer, Seller's liability under this Guaranty for misbranding shall be limited to liability for the failure, if any, of the articles to conform to the labels furnished to Seller by Buyer.

Provided further, that in the event Buyer chooses to arrange its own pick up of bulk product, then this Guaranty shall be valid only while Seller has direct physical control of the product at the shipping origin.

This guaranty supersedes all previous guaranties and shall be valid for two (2) years from the date set forth below or until such earlier time as written notice of revocation thereof is given to Buyer.

This letter is to provide you, a customer of Morton Salt, Inc. ("Morton Salt"), information regarding Morton Salt's compliance with California's Safe Drinking Water & Toxic Enforcement Act of 1986 (also known as "Prop 65"). 

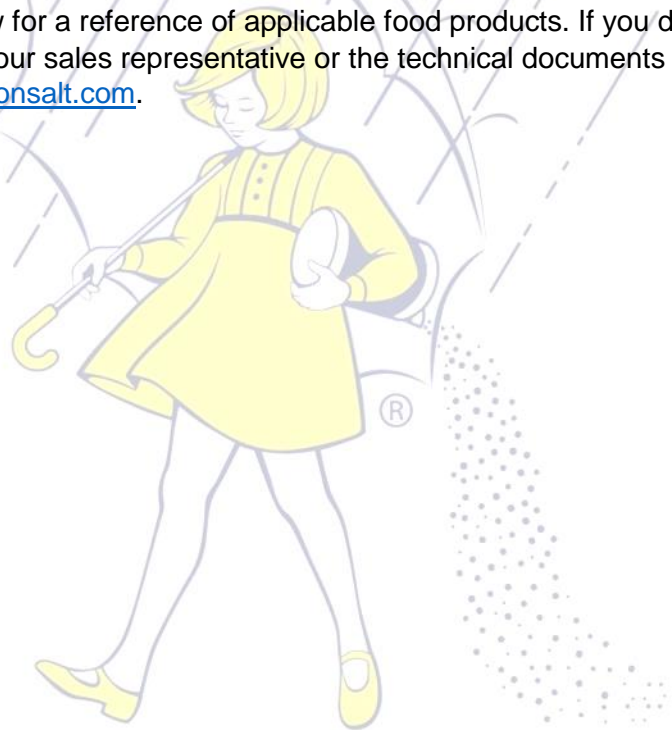

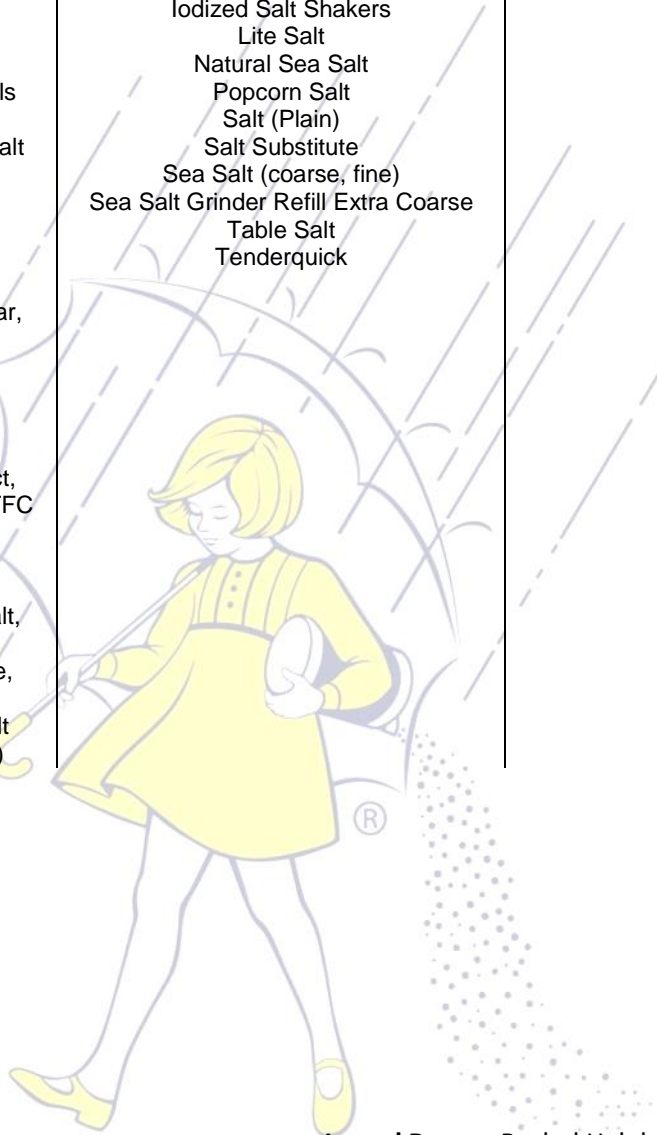
