As you are aware, Niacet has recently purchased Kemira ChemSolutions' food, pharmaceutical, propionate and acetate business along with their Tiel, Netherlands facility. We are pleased to inform you that Niacet has designed a new bag for the propionate product lines. This effort is being coordinated between Niacet's US and Netherlands locations. The design layout of the bag will be used for both facilities and we anticipate no change in specifications of product. The conversion has already begun and when completed, only Niacet's name will be shown, replacing the Kemira name on bags filled at our Netherlands facility. This is expected to be completed on or before July 31, 2013.

We will attempt to provide answers to some frequently asked questions:

- 1. Calcium Propionate sold to the North America market will be primarily produced in the US
- 2. Calcium Propionate sold to Europe will be primarily produced in the Netherlands
- 3. The Kemira ChemSolutions acquisition included the purchase of the "ProBake" trademark and will be used on the propionate product line at both facilities
- 4. Niacet's <u>Calcium Propionate LD</u> grade name will be changed to <u>Calcium Propionate Powder</u>
- 5. The bags will clearly state the country of manufacture
- 6. Bag construction will remain the same

In a continuing effort to improve our management systems, Niacet will be upgrading to a new SAP version in Q4 2015. We are excited about the many features we will gain with the new software version. We do not anticipate any negative effects for our customers; however, we would like to take this opportunity to inform you of some changes that will occur.

- 1. All item/material numbers will be re-numbered in the new system. We will reference the old item numbers in the master data of the new SAP system, allowing us the option to reference the old item numbers for product manufactured prior to the switch.
- 2. The current lot code will be replaced with a computer generated sequential 10 digit batch number. Current inventory at the time of cut over will carry a reference to the old lot number, allowing forward traceability to the point of sale. All history in the old system will be maintained to allow backward traceability to raw materials and packaging.
- 3. There will be changes in layout and appearance to the present documents provided, including invoices, order acknowledgments and certificate of analysis.
