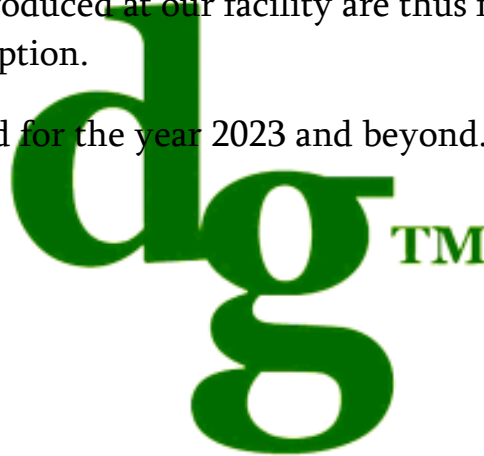

## Free of Dioxin and Pentachlorophenol

Haji Dossa Nutralgum (Pvt) Ltd, certifies that all guar gum products manufactured at our plant in Karachi, Pakistan do not contain chemicals such as Dioxin or Pentachlorophenol (PCP).

In Pakistan, guar seed is only grown on arid, rain-fed lands, which ensures that the crop is not affected by the above-mentioned chemicals.

In India, however, guar seed is grown on irrigated land, besides the cotton growing fields. The cotton growing cycle (July – October) require between two and three sprays of insecticides and pesticides.

All guar gum products produced by Haji Dossa Nutralgum (Pvt) Ltd. are produced using only Pakistani guar seed and are thus free from Dioxins and PCPs.
