To Whom It May Concern:

With respect to the use of raw materials IOI Group takes not only the economic but also the environmental and social impacts into consideration. The cultivation of palm oil and palm kernel oil is economically far more effective than other vegetable oils, but leads to environmental and social problems in the meantime, particularly in Southeast Asia because of the deforestation. IOI Group has been constantly taking active approaches to managing sustainability.

On the Oleochemical front, the switch to using sustainable palm oil and raw materials under the RSPO Supply Chain Certification Schemes, namely the Mass Balance and Segregation categories is based on 1) the request from the buyer mentioning which measure "Mass Balance" or "Segregated" to be used when placing an order, 2) the volume of the order(s) as minimum order quantities (MOQ) for the use of sustainable palm oil apply and 3) the amount of sustainable palm oil available for purchase from the commodity market. A premium will generally apply when sustainable palm oil is used. Purchases through the "Segregation" system will generally carry the highest extra cost. Nevertheless, it remains our ultimate objective to support RSPO and procure certified sustainable materials under the Segregated System to be used in the manufacturing of Oleochemical products.


