Included in this certification are all their European production sites and subsidiaries. All the industrial and retail products (food, feed and pharma grade), of rock, vacuum and sea salt and dishwashing salt, in various branch names, are strictly kosher. They do not contain or come in contact with any non-kosher substances during the whole production process. The salt is kosher parve, including for Passover.

Included in the kosher certification are the production plants in Bernburg, Grasleben, Ickenroth, Rheinberg (Germany), Dombasle (France), Barreda, Torrelavega, (Spain), Alverca, Olhão (Portugal). Included are the production plants in Hattorf, Wintershall, Zielitz (Germany), for potassium chloride, potassium sulfate and magnesium sulfate salts in food, feed and pharma grade, under various branch names. The kosher certification is being centralized by **K+S Minerals and Agriculture head office** in **Kassel Germany**.

The pure salt licks and mineral licks, in different stones, are kosher. The salt licks contain pure salt and the mineral licks contain additionally inorganic mineral additives.

This kosher certificate is signed 1 August 2023 and valid until 1 September 2025.
