- (a) not adulterated or misbranded or injurious to human health within the meaning of the Federal Food, Drug and Cosmetic Act, and all regulations and amendments thereto including the Food Additives Amendment, to the extent said Act is then effective and applicable, and that such articles are not articles which may not be introduced into interstate commerce under the provisions of Sections 404, 505, 512 of said Act;
- (b) manufactured in compliance with the requirements of 21 CFR 110 Current Good Manufacturing Practice in Manufacturing, Packaging, or Holding Human Food;
- (c) not in a misbranded package within the meaning of the Federal Hazardous Substances Labeling Act to the extent said Act is then effective and applicable;
- (d) in compliance with the requirements of the Poultry Products inspection and the Meat Inspection Act to the extent that such Acts are then effective and applicable; and
- (e) in compliance with and not adulterated or misbranded within the meaning of any identical or substantially similar state or municipal law on the subject, to the extent said law is then effective and applicable;

The Heavy Metals test currently provided on Morton's Certificate of Analysis includes all types of heavy metals including Lead, Mercury, Cadmium, etc. If any one of these metals or a combination of these metals reaches the limit (2 ppm for food products) the product is not acceptable as a food product. Therefore, the Heavy Metals test is equivalent or has a lower allowable limit for lead than a lead test by itself. To ensure that the procedure detects lead as a heavy metal, each analysis is run against a standard of lead at 2 ppm. In each case, if the sample has less heavy metals than the lead standard, the product is approved and passes Food Chemical Codex and Codex Alimentaius.
