

Subject: GMO Statement – Sugar Products

To: All Domino Foods, Inc. Valued Customers:

This statement is written in response to requests from our customers regarding the use of genetically engineered additives or ingredients in the manufacture of our powdered and confectioner's refined sugar products.

A Non-GMO Confectioners 6X, a Non-GMO Confectioners 12X, as well as organic and non-organic powdered raw cane sugar products, manufactured with an organic, non-GMO cornstarch, are available. For other regular grades of confectioner's and powdered products, we do not specifically purchase nor utilize cornstarch or maltodextrin that is genetically modified organism (GMO) free or identity preserved (IP). As such, we cannot make any claims regarding the GMO status of this family of confectioner's sugar products.

We assume and advise customers that all of the products listed below, which contain cornstarch or maltodextrin, are not GMO free. These products, including Confectioner's 4X, 6X, 10X and 12X, Set & Match, C&H Powdered Sugar, C&H Fondant & Icing Sugar and C&H Frost & Glaze Sugar, should not be utilized in products where GMO free status is stipulated or required.

C&H Red Sugar and C&H Rainbow Sugar, FreshVert Invert Sugar (Creamy) and Nulomoline Congealed should also not be utilized where GMO free status is required, as all ingredients have not been verified as totally GMO free.

Qwik-Flo® Honey Granules, Qwik-Flo® Honey Powder and Mate 'N Match Honey™ utilize honey that may not be GMO free. Organic Qwik-Flo® Honey Granules does utilize honey which is certified non-GMO.

This statement is written in response to requests from our customers regarding the use of genetically engineered additives or ingredients in the manufacture of our various refined sugar products.

Please be advised that, to our knowledge, all Domino® Sugar, C&H® Sugar, and Florida Crystals granulated, brown (soft) and liquid sugar products, and the following Specialty products and their ingredients are not developed using bioengineering or biotechnology: Amerfond® Fondant Sugar, DiPac® Direct Compacting & Tableting Sugar, Envision® Flavor and Texture Modifier, Super Envision®, Brownulated® Brown Sugar Granulated and Powdered Evaporated Cane Juice, FreshVert® Invert Syrup, Nulomoline® Invert Sugar, Easy Fond®, Nulofond®, Maltoline® ME Medium, Bakers Drivert®, Millhouse® Molasses, Light Brown Enrobing Syrup, NF Granulated Sugars, Qwik-Flo® Molasses Granules/Powder, Cane Refinery Syrup, and Sugarcane Molasses products.

Genetically modified cane sugar is not currently available commercially, but may be under investigation by cane sugar growers throughout the world. Unless specifically labeled as such, none of these products are certified organic, and none of these products are produced using a fermentation process.

The cane sugar refining process is well documented in literature and uses many historical and modern technologies to produce the wide array for cane sugar products sold by Domino Foods, Inc. The processes / technologies used within our refineries may include the use of some of the following process aids: lime, sodium hydroxide, phosphoric acid, carbon dioxide, hydrochloric acid, diatomaceous earth, ion exchange resin, activated carbon, natural charcoal, soda ash, flocculants, enzymes and citric acid. To the best of our knowledge, none of these process aids are derived from genetically-modified organisms. None of these chemicals and process aids remain in the final product. Any ingredients or additives including anti-caking agents beyond sugar are listed in the ingredient statement for the applicable product.

A Non-GMO Confectioners 6X product and a Non-GMO Confectioners 12X product, manufactured with an organic, non-GMO cornstarch is available.

With respect to the DiPac® Direct Compacting & Tableting Sugar product, this product does not intentionally* contain any genetically engineered additives or ingredients (*adventitious commingling may occur at the supplier's facility).

In addition, these same products are not considered genetically modified or are not derived from a genetically modified organism as defined by the European Community directives 1830/2003/EC on labeling and traceability and 1829/2003/EC on genetically modified food and feed and any impending legislation.
