# TiO2 Customer Change Control Notification-Part II





To Whom It May Concern:


Roha USA, L.L.C. guarantees that goods (articles) comprising each shipment delivered to Tilley, as of the date of delivery and when so labeled, shall be;

This is a continuing guarantee and will remain in force and in effect until termination in writing by an officer of Roha USA, L.L.C, given at least ten (10) days notice, or until expiration of this guarantee. This guarantee shall expire, without any action required by either party, on the last day of the fifteenth (15) month of any period in which the parties have not conducted business for a consecutive fifteen (15) months.
